To construct a new attached two car garage to the north east portion of the existing dwelling. The applicant is also proposing to convert the existing garage into habitable space and enclose the existing front porch.

- Proposed lot coverage of 32.20% of the lot area 1. WHEREAS a maximum lot coverage of 30.00% of the lot area is permitted;
- Proposed front yard setback of 2.68m 2. WHEREAS a minimum front yard setback of 5.25m is required;
- Existing and proposed east side yard setback of 1.22m 3. WHEREAS a minimum east side yard setback of 1.80m is required; and
- Proposed building length of 18.30m 4. WHEREAS a maximum building length of 16.80m is permitted.
