Notice was given and a Public Hearing was held on Wednesday, July 17, 2013, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

To construct a new two-storey detached dwelling with an integral two car garage. The existing dwelling would be demolished.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- Section 13.2.4, By-law No. 7625
 Proposed lot coverage of 35.0% of the lot area
 WHEREAS the maximum permitted lot coverage is 30% of the lot area;
- Section 13.2.3(b), By-law No. 7625
 Proposed north side yard setback of 1.75m
 WHEREAS the minimum required north side yard setback is 1.8m;
- Section 13.2.3(b), By-law No. 7625
 Proposed south side yard setback of 1.75m
 WHEREAS the minimum required south side yard setback is 1.8m;
- Section 6(30)a, By-law No. 7625
 Proposed finished first floor height of 1.92m
 WHEREAS the maximum permitted first floor height is 1.5m.

The Minor Variance Application is Approved on Condition

- 2. Where no street tree exists, the owner shall provide payment in an amount to cover the cost of planting a street tree abutting the site to the satisfaction of the General Manager of Parks, Forestry and Recreation.
