THE CONSENT REQUESTED:


To sever the property into two residential lots identified as Parts 1 and 2 on the attached lot division plan. The Retained Lot (Part 1) would have a frontage of 21.19 m and a lot area of 837.3 m². The Conveyed Lot (Part 2) would have a frontage of 21.19 m and a lot area of 961.4 m². The retained lot would maintain the existing dwelling and the conveyed lot would be developed with a new dwelling.

IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:

The Consent Application is Refused

The Committee has considered the provisions of Section 51(24) of the *Planning Act* and is not satisfied that the proposal conforms to the Neighbourhoods policies of the Official Plan. The proposed lot sizes would not maintain the established character of the existing residential neighbourhood. The application is therefore refused.
