PURPOSE OF THE APPLICATION:

To maintain the existing detached dwelling.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- 1. The existing/proposed north side yard setback is 0.79 m. Whereas the minimum required side yard setback is 0.9 m.
- 2. To permit two single family dwellings on one lot. Part 1 (retained lot) would have a lot frontage of 21.19 m and a lot area of 837.3 m.

Whereas one single-family dwelling is permitted per lot or block as shown on Registered Plan.
