PURPOSE OF THE APPLICATION:

To construct a new detached dwelling.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- 1. The proposed garage length is 9.6 m.
 - Whereas the maximum permitted dimensions of a garage are 7.6 m by 7.6 m.
- 2. To permit two single family dwellings on one lot. Part 2 (conveyed lot) would have a lot frontage of 21.19 m and a lot area of 961.4 m.
 - Whereas one single-family dwelling is permitted per lot or block as shown on Registered Plan.
- 3. The proposed driveway width is 8.23 m.
 - Whereas the maximum permitted driveway width is 6 m.
