The lot frontage is 6.18 m and the lot area is 181.4 m². The existing vacant parcel will be developed with a new detached dwelling with an integral garage and will require variances to the Zoning By-law, as outlined in Application A230/13EYK.

Easements/Right-of-Ways - Any existing easements/right-of-ways will be maintained.

File Numbers B30/13EYK, A229/13EYK AND A230/13EYK will be considered jointly.
