### **Proposed Revisions to the Toronto Official Plan Regarding Section 37 Policies Related to Affordable Housing**

#### **PROPOSAL – PURPOSE AND EFFECT**

The City of Toronto is currently undertaking a review of the Toronto Official Plan which was adopted by Council in 2002 and came into effect in 2006. The Official Plan housing related policies are part of this review. The review of the housing related policies is occurring in multiple stages. Proposed changes to the Official Plan Section 37 policies related to affordable housing are the first set of housing related policies under consideration.

Amendments to Official Plan policy 5.1.1.6 are proposed in order to: 1) explicitly authorize affordable ownership housing as an eligible Section 37 community benefit; and 2) permit condominium-registered rental units owned by a non-profit housing provider to be considered as an eligible Section 37 community benefit.

A staff report containing the draft Section 37 policies was considered by Planning and Growth Management Committee in September 2012, and may be viewed at <http://www.toronto.ca/legdocs/mmis/2012/pg/bgrd/backgroundfile-49671.pdf>. These draft policies were the subject of a public consultation meeting in November 2012. The proposed Official Plan Amendment will be the subject of a statutory public meeting on February 28, 2013. The proposed policies will be slightly different than the September 2012 draft policies as a result of feedback from the public.

The Planning and Growth Management Committee will review the proposal and any other material placed before it, in order to make recommendations on the Official Plan Amendment. These recommendations will then be forwarded to Toronto City Council for its consideration.

**Official Plan Amendment and Appeal:** If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Administrator, Planning and Growth Management Committee, at the address set out in this notice or by Fax: 416-392-1879 before the Council decision on the proposed Official Plan Amendment, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

**Notice to People Writing or Speaking to the Committee:** The City of Toronto collects any personal information in your communication or oral submission to Toronto City Council or its committees under the City of Toronto Act, 2006, the Planning Act and the City of Toronto Municipal Code.
