# Proposed Signage Master Plans Concerning the Display of Third Party Wall Signs at 19 Locations Within Multiple Wards - Titan Outdoor

#### Summary

This report reviews and makes recommendations on amendments to Chapter 694, Signs, General, of the City of Toronto Municipal Code, to implement a Signage Master Plan for Titan Outdoor consisting of 21 large format third party wall signs at 19 locations in Wards: 14, 19, 20, 21, 22, 27, and 28.

As part of the sign regulations contained in Chapter 694, Signs, General, the City has

introduced the ability for individuals to obtain amendments to implement a Signage Master Plan to set out specific regulations for the location, arrangement, type and design of signs at a specific location or area.

As well as promoting the objectives of Chapter 694, adoption of this Signage Master Plan will resolve outstanding litigation with Titan Outdoor and allow for improved enforcement of Chapter 694.

Staff recommends approval of the requested amendment to Chapter 694 to introduce the Signage Master Plans for the 19 specific premises described in this report.
