

City of Toronto Act, 2006 Public Notice

Notice is given that the Chief Building Official and Executive Director, Toronto Building, is reporting on a proposal which seeks to amend Chapter 694, Signs, General, of the City of Toronto Municipal Code.

This proposal seeks to permit the modification of the west side of the sign located at 2 Strachan Avenue to replace two existing sign faces with three new sign faces displaying mechanical and electronic static sign copy.

An amendment to Chapter 694 is required because the sign is located in an OS-Open Space Sign District where no third party signs are permitted. Since the proposed changes constitute a substantial alteration to the existing sign, the updated sign is required to comply with Chapter 694.

The Planning and Growth Management Committee may propose that the Council of the City of Toronto amend Chapter 694, Signs, General, to introduce an area-specific amendment to permit the proposed sign.

The Chief Building Official and Executive Director, Toronto Building is recommending that the Council of the City of Toronto amend Chapter 694, Signs, General, of the City of Toronto Municipal Code, in the manner proposed above.

At its meeting to be held in Toronto City Hall, Committee Room 1, on January 28, 2013 commencing at 10:00 a.m., or as soon as possible thereafter, the Planning and Growth Management Committee of Toronto City Council will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
