## City of Toronto Act, 2006 Public Notice

Notice is given that the Chief Building Official and Executive Director, Toronto Building, is reporting on a proposal which seeks to amend Chapter 694, Signs, General, of the City of Toronto Municipal Code.

The proposal seeks to amend Chapter 694 to permit one large-format third party sign on the roof of an existing two-storey commercial building. The proposed roof sign is intended to contain three sign faces, each facing northerly, easterly and southerly, and each displaying electronic static copy. The building is located on the west side of Yonge Street, at the intersection of Yonge Street and Gerrard Street, within the Downtown Yonge Street Special Sign District (DYS-SSD).

The Planning and Growth Management Committee may propose that the Council of the City of Toronto amend Chapter 694, Signs, General, to introduce an area-specific amendment to permit the proposed sign.

The Chief Building Official and Executive Director, Toronto Building, is recommending that the Council of the City of Toronto amend Chapter 694, Signs, General, of the City of Toronto Municipal Code, in the manner proposed above.

At its meeting to be held in Toronto City Hall, Committee Room 1, on June 20, 2013 commencing at 9:30 a.m., or as soon as possible thereafter, the Planning and Growth Management Committee of Toronto City Council will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
