## City of Toronto Act, 2006 Public Notice

Notice is given that the Chief Building Official and Executive Director, Toronto Building, is reporting on a proposal which seeks to amend Chapter 694, Signs, General, of the City of Toronto Municipal Code.

## This report proposes:

- Amendments to the Sign By-law ("Chapter 694") to reduce the number of criteria for considering sign variance applications;
- Modifying the provisions concerning Signage Master Plans;
- Requiring a Signage Master Plan where more than three signs on a premise require variances to the regulations in Chapter 694;
- Changes to performance standards for first party signs within Chapter 694;
- Adding and modifying certain provisions to clarigy issues concerning points of intersection as well as the site-specific amendment process;
- Modifying the definition of Fence; and
- Changes to the Sign District designations for 67 locations in 11 Wards to make the designations of these premises consistent with their current use.

The Chief Building Official and Executive Director, Toronto Building is recommending that the Council of the City of Toronto amend Chapter 694, Signs, General, of the City of Toronto Municipal Code, in the manner proposed above.

At its meeting to be held in Toronto City Hall, Committee Room 1, on June 20, 2013 commencing at 9:30 a.m., or as soon as possible thereafter, the Planning and Growth Management Committee of Toronto City Council will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
