PROPOSAL

The application to amend the Zoning By-law proposes to reduce the minimum required lot frontage from 21 metres as currently set out in the zoning by-law, to 15 metres in order to permit the existing 5 lots at 1383, 1385, 1389, 1399 and 1403 Military Trail to be severed into 12 new lots for detached residential dwellings. The application also proposes some site specific performance standards for the dwellings, and to rezone the rear portions of the lands from Single Family Residential (S) Zone to Major Open Spaces (O) Zone.

This land is also subject to applications under the Planning Act for consent, Application Nos. B003/12SC, B004/12SC, B005/12SC, B006/12SC and B007/12SC.

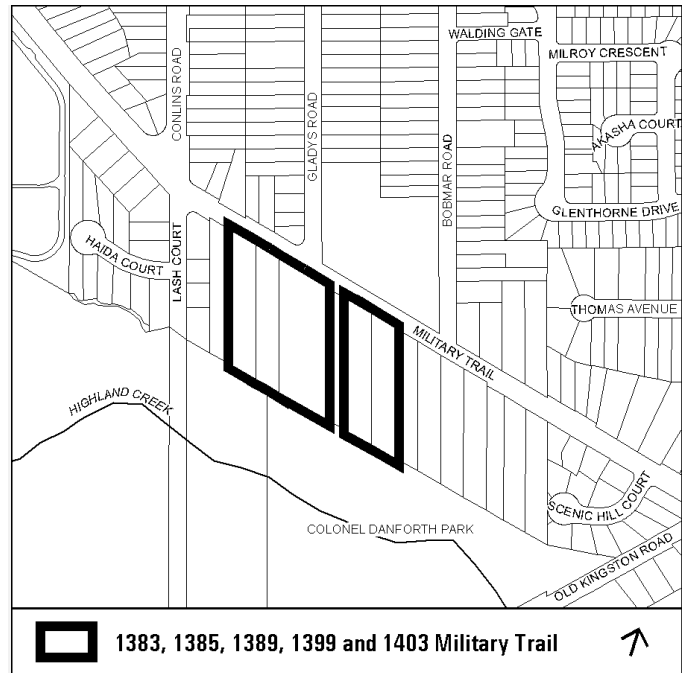
FURTHER INFORMATION

If you wish to be notified of the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301.

Zoning By-law Amendment Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301 before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
