# NOTICE OF PUBLIC MEETING

#### **PROPOSAL**

This is a re-notification of the City-initiated amendment to the Official Plan that proposes to clarify the land use designation applying to the property located at the southwest corner of Morningside and McNicoll Avenues in order to avoid any ambiguity as to the land use policies that apply to this property. Specifically, the proposed amendment would re-designate the subject property from a 'Neighbourhoods' designation to an 'Employment Areas' designation. The proposed amendment would also reflect and correlate with the designation which existed in the former Scarborough Official Plan.


Official Plan and Zoning By-law Amendment Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301 before the proposed Official Plan Amendment is adopted or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

**People writing or making presentations at the public meeting:** The City of Toronto Act, 2006, the Planning Act, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to

City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s).
