PROPOSAL

The application to amend the Official Plan and Zoning By-law proposes to accommodate a 2-phase development consisting of a total of 414 dwelling units in stacked townhouse and apartment building built forms. Specifically, the proposal would increase the permitted density from 326 to 414 dwelling units, with 105 stacked townhouses being proposed in Phase 1, and 2 apartment buildings of 13 and 18-storeys proposed in Phase 2. Additional commercial uses are proposed as part of the Phase 2 portion of the development. The subject lands are collectively known as 1088 Progress Avenue.

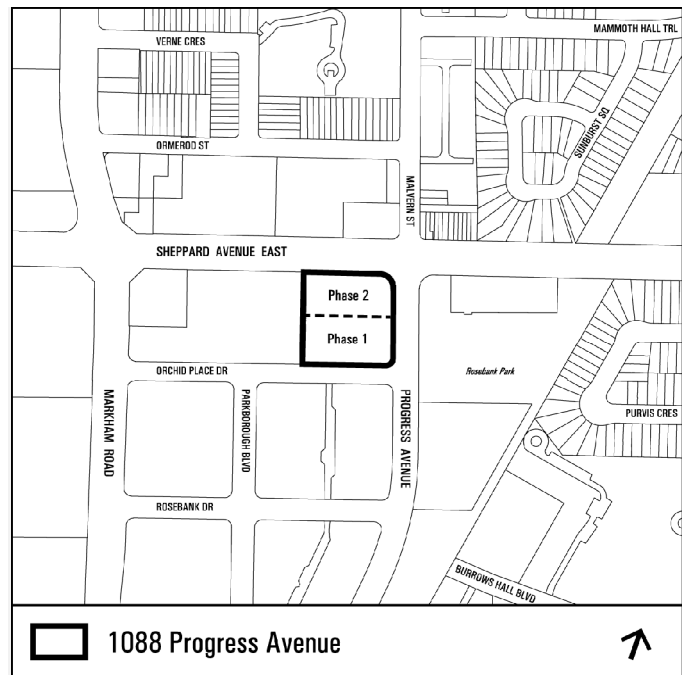
FURTHER INFORMATION

If you wish to be notified of the adoption or refusal of the proposed Official Plan Amendment and/or passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301.

Official Plan and Zoning By-law Amendment Appeals: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301 before the proposed Official Plan Amendment is adopted or refused and/or Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s).
