PROPOSAL

In 2010, City Council enacted Zoning By-laws 222-2010 and 614-2010 in order to implement the adopted vision for the reurbanization of Kingston Road between Victoria Park Avenue and Birchmount Road. The purpose of that study was to encourage the revitalization of Kingston Road within the Birch Cliff Community, thereby achieving a vibrant and sustainable mixed use corridor that promotes a compatible built form, beautiful streetscapes, high quality architecture and economic prosperity.

The proposed Zoning By-law Amendment corrects minor technical discrepancies between the reurbanization vision adopted by City Council and the performance standards applied to various properties targeted for mixed use development within the study area. Zoning standards to be revised, and site-specific exceptions to be deleted, relate to, among others: permitted uses, parking and access, building setbacks, 45-degree angular plane provisions, density, height and Section 37 community benefits.

Zoning By-law Amendment Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, 150 Borough Drive, Toronto, Ontario, M1P 4N7, or by Fax: 416-396-4301 before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website.
