BY-LAW No. ~-20~

To amend ~ Zoning By-law No. 569-2013~, With respect to the lands along Queen Street West between Dufferin Street and Roncesvalles Avenue

Whereas authority is given to Council by Section 34 of the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and

Whereas Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the *Planning Act*;

The Council of the City of Toronto enacts as follows:

1. By-law 569-2013 is amended to insert section 600.50.10 (1), so that it reads:

600.50 Community Overlays 600.50.10(1) Queen Street West Restaurant Policy Area

Within the area of the heavy lines on the Queen Street West Restaurant Policy Area Overlay Map (Schedule ???) in By-law (Clerk to add amending by-law number) and identified as areas "A", "B", "C" and "D" the following applies:

- (A) a cabaret, eating establishment, entertainment place of assembly, and take-out eating establishment may only be on a lot that has its front lot line or side lot line abutting Queen Street West;
- (B) for the portion of a **building** containing a **cabaret**, **eating establishment**, **entertainment place of assembly** and **take-out eating establishment** the aggregate surface area of all operable windows and doors located in any **main wall** of the first **storey** and facing a **rear lot line** or a **street** other than Queen Street West, must not be greater than 4.0 square metres;
- (C) a cabaret, eating establishment, entertainment place of assembly and take-out eating establishment or any ancillary use, may not be located above the first storey.
- (D) an **outdoor patio**, may be located on the **lot**:
- (i) between the front **main wall** of the **building** and a **front lot line** that abuts Queen Street West, or
- (ii) between the **main wall** and a **side lot line** that abuts a **street**, if it is no further from the **front lot line** then 50% of the **building depth**; and

- (E) in a **building**:
- (i) the **total interior floor area** used for any one or combination of a **cabaret**, **eating establishment**, **entertainment place of assembly**, and **take-out eating establishment** or **ancillary** use may not exceed 200 square metres, excluding any rooms used exclusively for the preparation of food, storage, washrooms, electrical, utility, mechanical or ventilation; and (ii) if adjoining uses in (E)(i) above are connected by internal passageways used by patrons or staff, the total **interior floor area** of all the connections must be included for the purpose of calculating (E)(i) above; and
- (F) a **building** may not be erected or used for the purpose of an **eating establishment**, if it results in the total number of all **eating establishments** within the area on the Queen Street West Restaurant Policy Area Overlay Map (Schedule ??? of By-law #(Clerk to add amending by-law number) exceeds the following number:

Within Area A, 22

Within Area B, 18

Within Area C, 21

Within Area D, 14

- (G) the following uses are permitted with an **entertainment place of assembly**: teletheatre gambling; a sound room; an area dedicated to recreational activities, but not a dance floor or disc jockey; and any other entertainment area, but not a area for a dance floor or disc jockey, if the total combined area of these uses is the lesser of:
- (i) 6% of the total interior floor area of the eating establishment; and
- (ii) a maximum of 12 square metres
- (H) despite regulation 150.100.20(1)(A) the following uses are permitted with an **eating establishment**: teletheatre gambling; a sound room; an area dedicated to recreational activities, but not a dance floor or disc jockey; and any other entertainment area, but not a area for a dance floor or disc jockey, if the total combined area of these uses is the lesser of:
- (i) 6% of the total interior floor area of the eating establishment; and
- (ii) a maximum of 12 square metres.
