

Realignment of Permit Parking Area "2-" to exclude 1544 Dundas Street West

SUMMARY

Transportation Services is requesting authority from City Council to amend the boundary of Permit Parking Area 2-.

Transportation Services has assessed the realignment of permit parking Area "2-" to exclude the property located at 1544 Dundas Street West, as requested by City Council. We are recommending approval of the realignment as it will not impact negatively on the Permit Parking Area.

RECOMMENDATIONS

Transportation Services recommends that:

1. City Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "2-", as attached in Appendix "A" of the report (August 14, 2013) from the Acting Manager, Right of Way Management, Transportation Services, Toronto and East York District.

FINANCIAL IMPACT

There is no financial impact associated with this report.

ISSUE BACKGROUND

City Council at its meeting of June 11, 12 and 13, 2013 in considering the final report for the zoning by-law amendment – 1544 Dundas Street West, item TE24.5, requested that Transportation Services examine and report back to Toronto and East York Community Council regarding the need for realignment of parking area "2-", and the exclusion of 1544 Dundas Street West from the permit parking area.

COMMENTS

Permit parking area "2-" is bounded by Parkside Drive, Bloor Street West, Dufferin Street and the Gardiner Expressway. Permit area "2-" has a total of 5,764 on-street parking spaces. To date 4,112 permits have been issued. This area does not have a history of being waitlisted, meaning the demand for overnight on-street parking permits has never exceeded the supply of parking spaces. There is TTC service on Dundas Street West. The Councillor and residents neighbouring 1544 Dundas Street West support this action as a means of ensuring that this new development does not negatively impact the permit parking supply to the existing neighbourhood.

As required under the City of Toronto Municipal Code, Chapter 925, Permit Parking, the General Manager requested the City Clerk to provide Notice. A Public Notice was placed in a major newspaper requesting those objecting to the exclusion of 1544 Dundas Street West, from permit parking area "2-" to forward their objections in writing to the City Clerk, so they may be scheduled as deputations at the Toronto and East York Community Council meeting.

Transportation Services has no objection to the exclusion of 1544 Dundas Street West from permit parking area "2-".
