Standing Prohibition - Stadium Road

SUMMARY

This staff report is about a matter for which the Toronto and East York Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting authority to prohibit standing on the west side of Stadium Road, between Lake Shore Boulevard West and a point 62 metres south. This proposed change will allow safe and efficient two-way traffic operation on Stadium Road and provide adequate visibility for motorists exiting the parking garage to No. 90 Stadium Road.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

1. Enact a "No Standing Anytime" regulation on the west side of Stadium Road, between Lake Shore Boulevard West and a point 62 metres further south.

Financial Impact

Funds to undertake the necessary signage adjustments in the estimated amount of \$500.00 are contained in the Transportation Services Division 2013 Operating Budget.

ISSUE BACKGROUND

At the request of Councillor Adam Vaughan, Transportations Services reviewed the parking regulations on the west side of Stadium Road, between Lake Shore Boulevard West and the driveway to the parking garage for No. 90 Stadium Road. There are

concerns with parked vehicles causing traffic congestion on Stadium Road and obstructing visibility for motorists exiting the parking garage.

COMMENTS

Stadium Road is an 8-metre wide, two-way local road that runs south from the signalized intersection with Lake Shore Boulevard West. No. 90 Stadium Road is located on the west side of the road, south of Lake Shore Boulevard West. Parking is prohibited on both sides of Stadium Road within 30.5 metres of Lake Shore Boulevard West. Otherwise, parking is allowed for up to three hours on the west side of the road and prohibited at all times on the east side. There is no TTC Service on Stadium Road.

Observations revealed when vehicles are parked on the west side of Stadium Road, from 30.5 metres south of Lake Shore Boulevard West to the driveway to No. 90 Stadium Road, two-way traffic operation is impeded. Also, visibility for motorists exiting the parking garage is obstructed. Prohibiting standing on the west side of Stadium Road, between Lake Shore Boulevard West and one parking space south of the driveway to No. 90 Stadium Road should remedy this problem. Also, the proposed standing prohibition would prevent accessible parking permit holders from parking in this area.
