Community Council meetings and City Council meetings are scheduled for the following dates in 2014:

- **February 25, 2014 (City Council on March 20, 2014)**
- **April 8, 2014 (City Council on May 6, 2014)**
- **May 13, 2014 (City Council on June 10, 2014)**

- **June 17, 2014 (City Council on July 8, 2014)**
- **August 12, 2014 (City Council on August 27, 2014)**

Please remember that requests for designating events of municipal significance or producing letters of non-objection for the purposes of Liquor Licencing (Special Occasions Permits and extensions) should be submitted to the City Clerk's Office **3 weeks prior to Community Council meeting date** in order to be considered and should be considered **2 to 3 months in advance of your event**. **This document is required by the Alcohol and Gaming Commission (AGCO) to process your SOP application.**

Please review the meeting dates to ensure your request is submitted well in advance of your event, and refer to the AGCO website below for information on SOP application deadlines (deadlines can be from 30 to 60 days prior to your event; and your request to Community Council should be complete prior to those deadlines.)

**Urgent Note:** As 2014 is a City of Toronto election year the **Final Community Council Meetings for 2014 will be held August 12, 2014** (with City Council on August 27, 2014).

**Any requests related to events occurring from mid-August until year end should be submitted for consideration in early August.**
