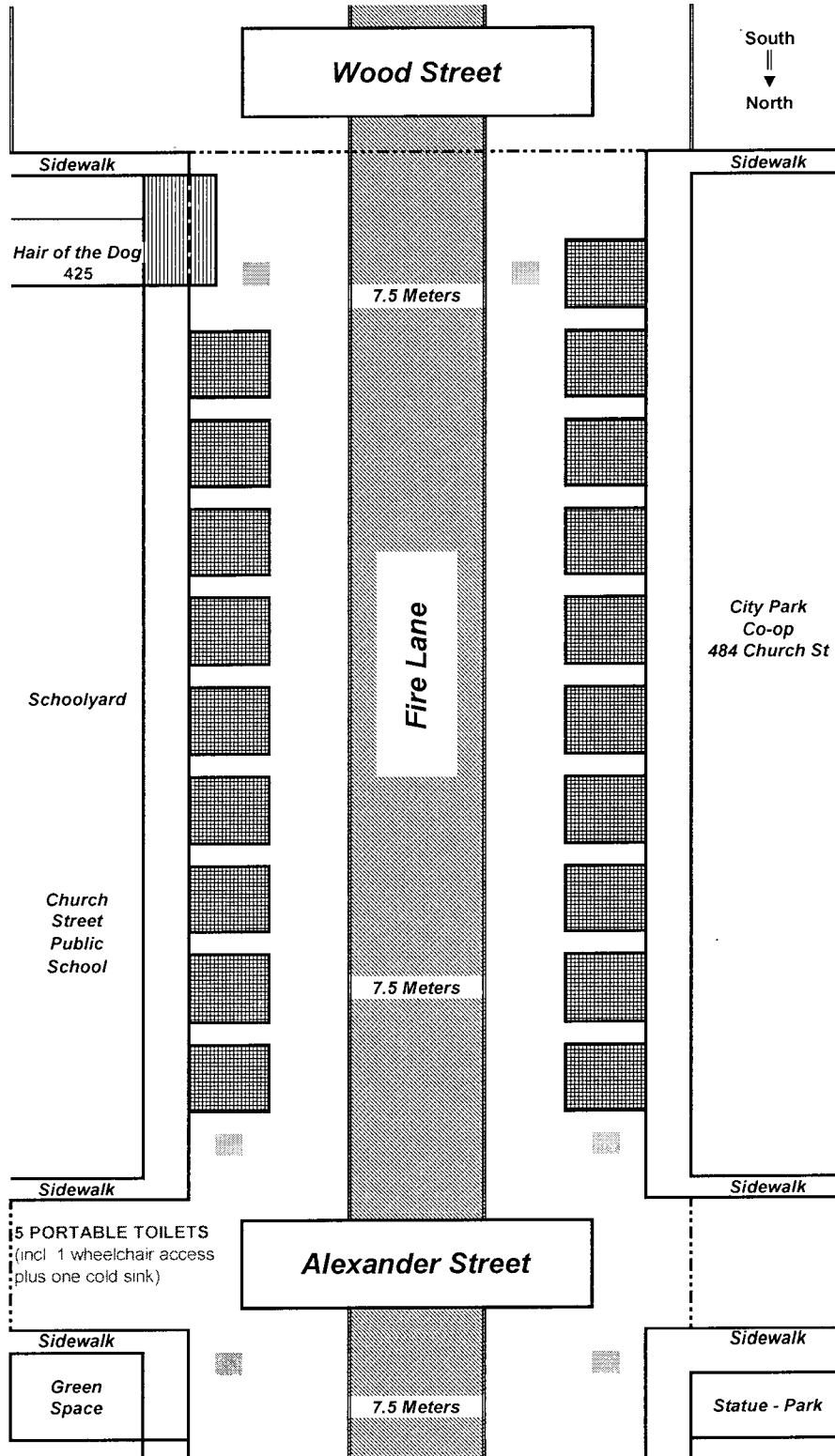
The Village Welcomes The World - Street Map

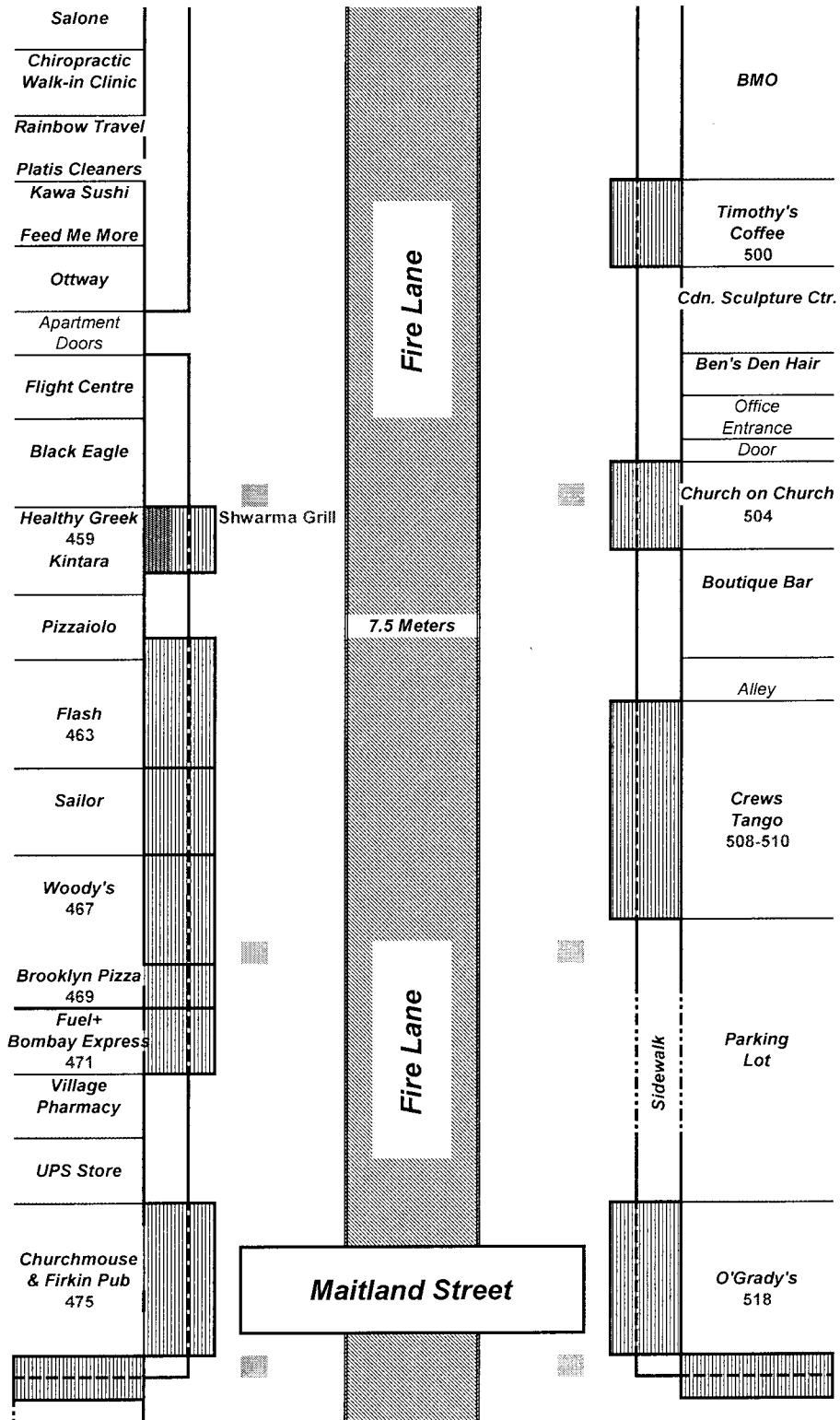

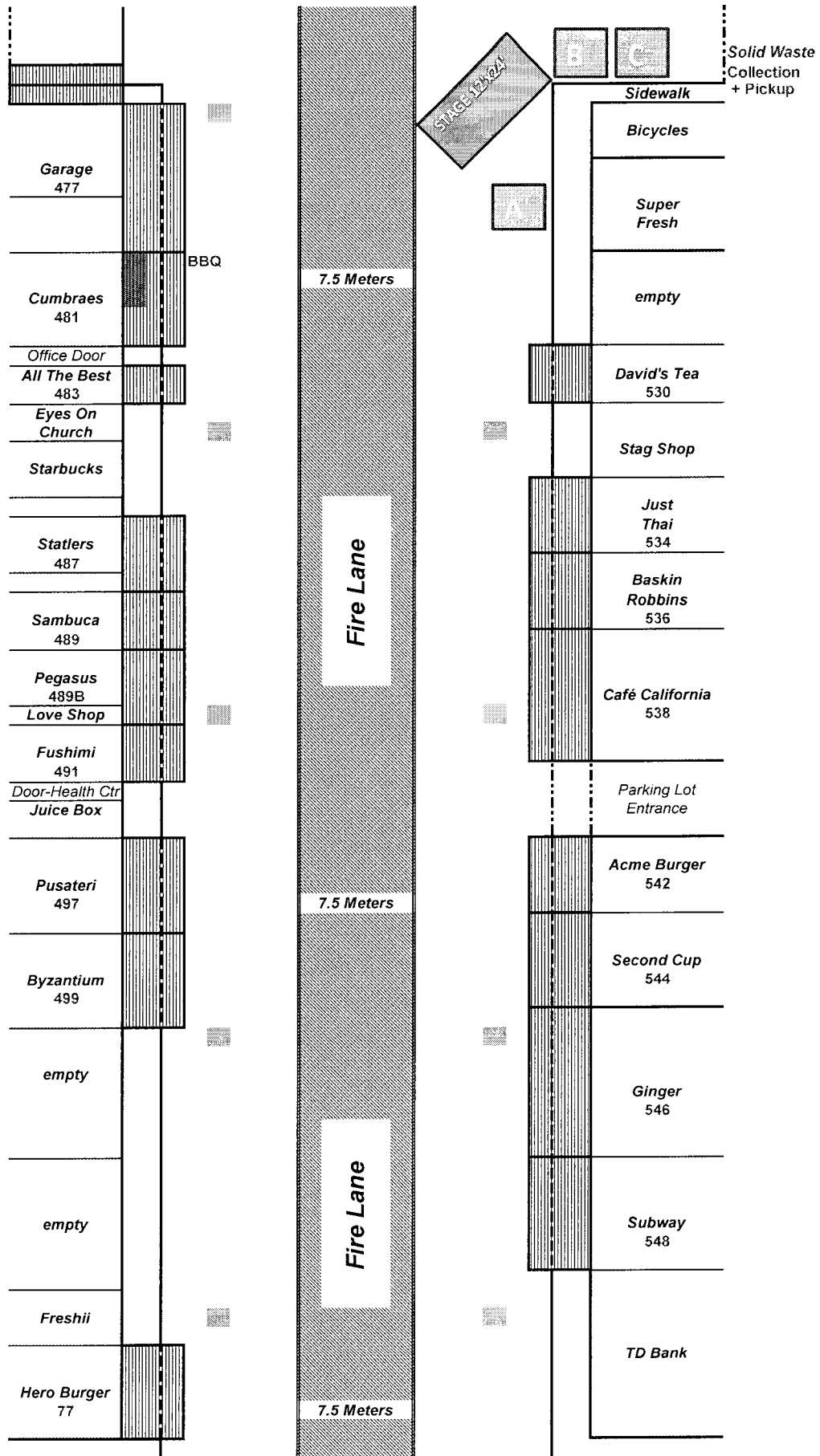

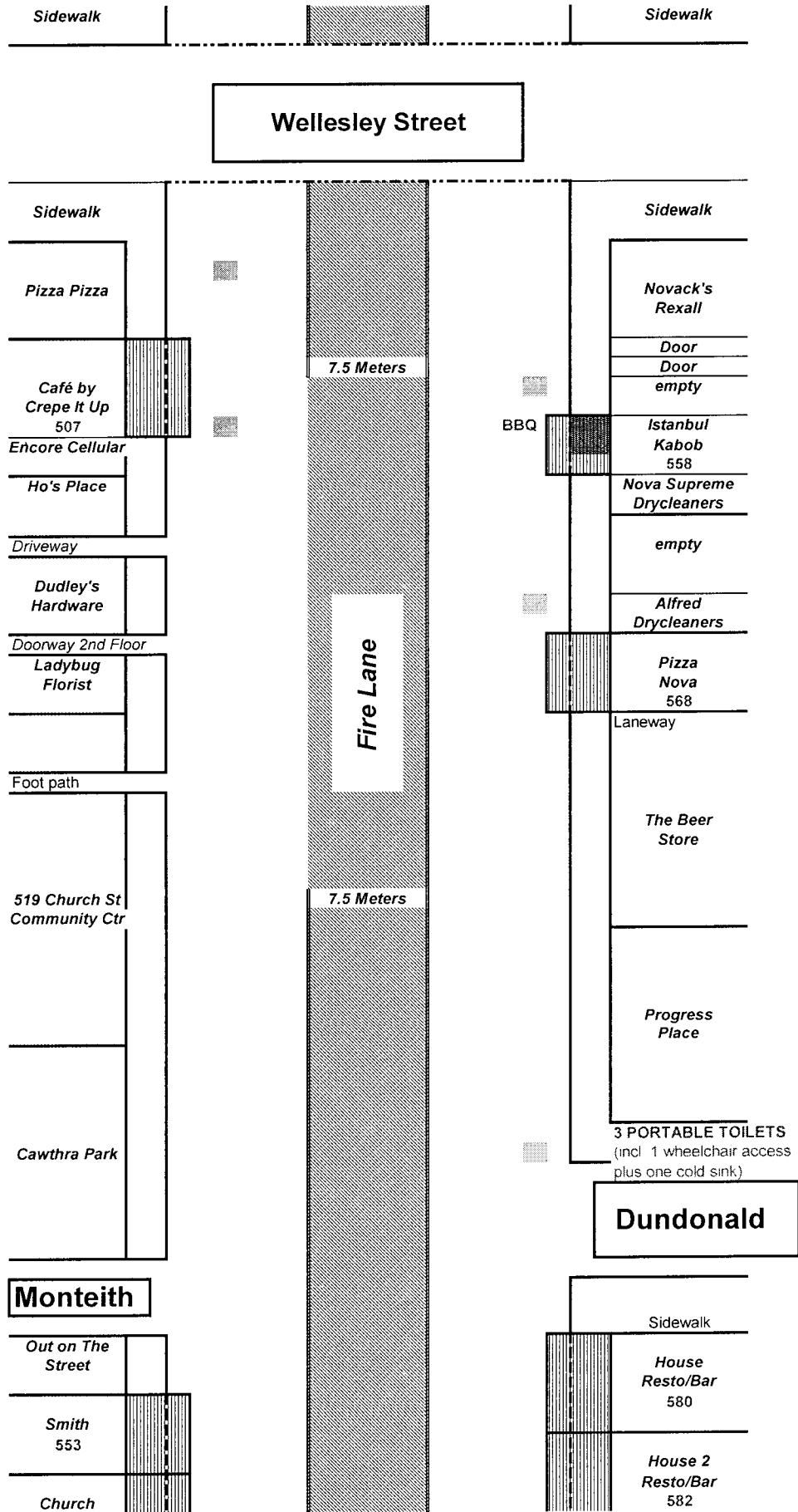

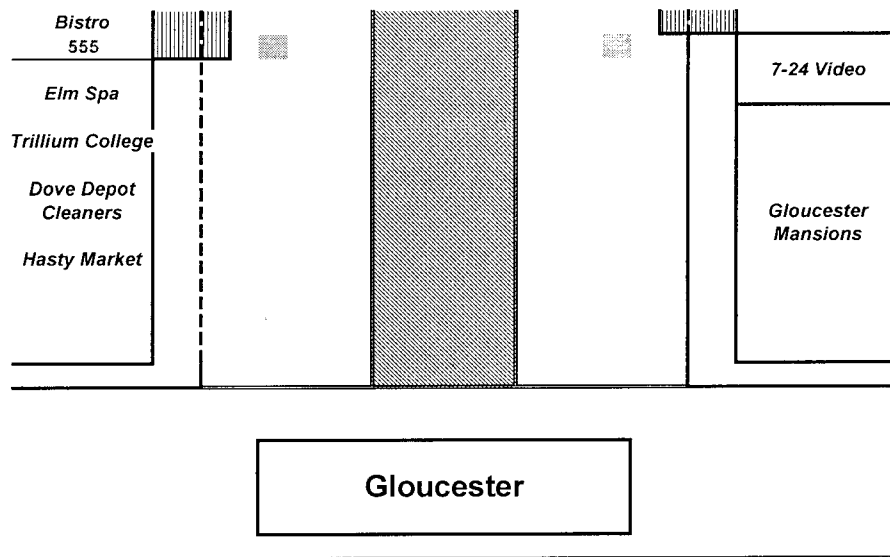

NOTES:

1. Food Preparation + Sale

Most food establishments will be preparing food in their existing (indoor) kitchen facilities to be served on their patio extension areas.

All food vendors are advised they must have a Certified Food Handler at all times.

All food vendor extended patio locations will be set up to meet Toronto Public Health requirements with regard to covers and temperature controls.

There will be barricaded barbeques at the following locations:

- The Healthy Greek 459 Church Street

- Cumbraes 481 Church Street

- Istanbul Kababob 558 Church Street

The BIA office will coordinate with Toronto Fire Services regarding these installations.

2. Wellesley will remain open to east-west vehicular traffic.

3. Handwashing stations for the general public will be maintained throughout the event and all portable toilet setups include one fully-accessible unit.

4. A complete site walkthrough will be executed during the initial street closure and temporary ramps will be installed as required to ensure accessibility at all patio locations.

5. A 7.5m fire lane will be maintained throughout the full length of the closed portion of Church Street for the duration of the event.

6. "Last call" for alcoholic beverage requests is 22:00. All alcohol to be removed from patio extensions by 23:00.

7. All vendor tent installations include sandbag weights to secure them in place.

8. All event entertainment will be restricted to the designated performance area, which is the stage at Church and Maitland. All entertainment presentations end at 23:00.
