## **Summary**

The Board of Directors of the Hummingbird (Sony) Centre for the Performing Arts (the "Board") met on May 1, 2014, to consider the Sony Centre's search for a new Chief Executive Officer (CEO) and Member Motion MM48.31. As a result, the Chair is now submitting confidential information to City Council through the City Manager in response to City Council's request in MM48.31.

The submission by the Chair outlines the Board's CEO recruitment and selection process and references the Theatres Working Group and the City's theatres study initiatives and outlines terms and conditions that the Board will include in the employment contract with the CEO. This submission includes confidential information that relates to personnel matters and includes personal information about parties to the Board's process.
