### THE CONSENT REQUESTED:

This application is for consent to sever the land into two lots, as shown on the attached Lot Division Plan. The owner is proposing to demolish the existing house and build two new detached houses. The lot shown as Part 1 would have a lot area of  $696 \text{ m}^2$ . The lot shown as Part 2 would have a frontage of 15 m on Ivan Road and a lot area of  $556 \text{ m}^2$ . The applicant applied for a variance for the land shown as Part 2 (File A023/14SC).


#### IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:

- The proposed land division does not conform to the policies of the official plan.
- The suitability of the size and dimensions of the proposed lots has not been demonstrated.
