Notice was given and a Public Hearing was held on Thursday, April 24, 2014, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

To legalize and to maintain the existing 6 buildings constructed without building permits.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. Section 60.20.40.70.(1), By-law 569-2013 and Section 304-36.B.(2)

The minimum required front yard setback is 3 m.

Buildings 2 and 3 are located 1.5 m from the front lot line.

2. Section 60.20.40.70.(3), By-law 569-2013

The minimum required rear yard setback is 7.5 m.

The buildings are located 0 m from the rear lot line, at the closest point.

3. Section 60.20.50.10.(1), By-law 569-2013

A minimum 3 m wide strip of soft landscaping is required along the entire length of the front lot line. **Section 304-36.B.(2)**

A minimum 3 m wide strip of landscaping is required along the entire length of the front lot line.

No landscaping will be provided along the front lot line.

IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:

The Minor Variance Application is Refused

It is the decision of the Committee of Adjustment to **NOT** approve this variance application for the following reasons:

- The general intent and purpose of the Official Plan is not maintained.
- The general intent and purpose of the Zoning By-law is not maintained.
- The variance(s) is not considered desirable for the appropriate development of the land.

• In the opinion of the Committee, the variance(s) is not minor.
