Re: Report request: Proposed 30 km/h road speed limit throughout Leaside

Residents within the Leaside Community have expressed their concerns with regards to traffic infiltration and vehicle speeds within the local community.

The land uses within the Leaside Community consist of single family residential properties, schools, parks and green spaces. Installation of 30 km/h speed limit zones will improve pedestrian and motorist safety throughout the community.

Therefore, in view of the residents concern, I am requesting that North York Community Council approve the following:

**RECOMMENDATIONS:**

1. North York Community Council instruct the Director, Transportation Services for North District to investigate and report to the next regular meeting of North York Community Council on the feasibility of implementing a 30 km/h speed limit on the following roadways:
  - I. Parklea Drive between the west end of Parklea Drive and Laird Drive;
  - II. Vanderhoof Avenue between Rumsey Road and Laird Drive;
  - III. Crofton Road between Rumsey Road and Sutherland Drive;
  - IV. Parkhurst Boulevard between Bayview Avenue and Laird Drive;
  - V. Sharron Drive between Cameron Crescent and Rumsey Road;
  - VI. Crandall Road between Hanna Road and McRae Drive;
  - VII. Field Avenue between Macnaughton Road and McRae Drive;
  - VIII. St. Cuthberts Road between Bayview Avenue and Bessborough Drive;
  - IX. Markham Avenue between Airdrie Road and Laird Drive;
  - X. Lea Avenue between Airdrie Road and Laird Drive
  - XI. Heath Road between Rumsey Road and Airdrie Road;
  - XII. Donegall Drive between Millwood Road and Fleming Crescent;
  - XIII. Fleming Crescent between Bayview Avenue and Dongall Drive (north intersection);
  - XIV. Cameron Crescent between Donegall Drive and the north end of Cameron Crescent;
  - XV. Bessborough Drive between Sutherland Drive and to the north end of Bessborough Drive (south of Eglinton Avenue East);
  - XVI. MacNaughton Road between Millwood Road and Cameron Crescent;
  - XVII. Hanna Road between Leacrest Road and Eglinton Avenue East;

- LIII. Killdeer Crescent between Brentcliffe Road (south intersection) and Brentcliffe Road (north intersection);
- LIV. Kilgour Road between Bayview Avenue and the east end of Kilgour Road; and
- LV. Burkebrook Place between Kilgour Road and the north end of Burkebrook Place.
