## NOTICE OF PUBLIC MEETING

To be held by the Planning and Growth Management Committee (Under the Planning Act)

Proposed Amendments to City of Toronto Zoning By-law No. 569-2013 Regarding the Residential Apartment Commercial Zone

## **PROPOSAL**

The City of Toronto is proposing to enact amendments to the City-wide Zoning By-law 569-2013, which regulates the use of the land, the size and location of buildings and structures, parking and loading. These amendments:

- 1. revise several regulations of the Residential Apartment Commercial (RAC) zone in Chapter 15;
- 2. revise the zoning map to change the current zone labels of many apartment properties from "RA" to "RAC"; and
- 3. where applicable, change Chapter 900 Site Specific Exceptions to the RA zone which currently apply to those apartment properties into Site Specific Exceptions to the RAC zone, and revise the text of the Exceptions to be consistent with the set of uses and related use-conditions of the RAC zone.

The RAC zone permits a number of small-scale uses on apartment building sites, which are expected to contribute to the vibrancy and diversity of apartment neighbourhoods. The uses may include, for example, small shops, food markets, cafes, learning centres, personal service shops, and offices. There are size limits for these uses which ensure they serve only their local area.

These changes may affect the approval of building permits, zoning certificates or other applications for a minor variance, a consent to sever, an amendment to a zoning by-law, an Official Plan amendment or a Minister's zoning order and any appeals of these matters, as well as outstanding appeals of Zoning By-law 569-2013. All land owners and applicants should review the proposed amendments to Zoning By-law 569-2013 carefully, and consult with your professional advisors about the proposed changes and how they may impact your lands or development applications.

The City will be holding a statutory public meeting prescribed by section 34(12) of the Planning Act, R.S.O. 1990, c. P.13 as amended and O. Reg 545/06 to ensure that sufficient information and material is made available to enable the public to understand generally the proposed amendments to Zoning By-law 569-2013, and to give the public an opportunity to review and ask questions about the information and material, as well as make representations in respect of the proposed amendments.

## **BACKGROUND INFORMATION**

- 4. i. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Clerk, City of Toronto before the proposed amending By-law is passed, the person or public body is not entitled to appeal the decision of council of the City of Toronto to the Ontario Municipal Board.
  - ii. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Clerk, City of Toronto before the By-law is enacted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
