PROPOSAL

The applications to amend the Official Plan and Zoning By-laws (By-law No. 563-2013, former City of Toronto Zoning By-law No. 438-86 and former City of York Zoning By-law No. 1-83) would permit additional potentially sensitive non-residential uses on the lands at 150 Symes Road. The proposed development would include the re-use of the existing heritage building and existing service garage, plus the addition of four new buildings on the west and north portions of the site.

In addition the proposed amend to the Zoning By-laws would modify performance standards with respect to building setbacks and landscape requirements and would include "H" Holding Symbol for an outdoor patio and education uses.

This land is also subject to an application under the Planning Act for Site Plan Approval Application No.:13 201956 WET 11 SA.


If you wish to be notified of the adoption or refusal of the proposed Official Plan Amendment and/or passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, attention: Nancy Martins, Administrator, Planning and Growth Management Committee, at the address set out in this notice or by fax to 416-392-1879.

Official Plan and Zoning By-law Amendments Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Nancy Martins, Administrator, Planning and Growth Management Committee, at the address set out in this notice or by fax to 416-392-1879 before the proposed Official Plan Amendment is adopted or refused and Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the

Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

People writing or making presentations at the public meeting: The *City of Toronto Act*, 2006, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s).
