City of Toronto Act, 2006 Public Notice

Notice is given that the Chief Building Official and Executive Director, Toronto Building, is reporting on a proposal to amend Chapter 694, Signs, General, of the City of Toronto Municipal Code to permit:

- the alteration of two roof signs located on the Ricoh Coliseum;
- the alteration of one three-sided ground sign; and,
- the addition of one sign face on an existing scoreboard structure located at BMO Field, all within Exhibition Place.

All signs are proposed to display static and electronic static sign copy which will be restricted to the advertising or promoting products and sponsors related to Exhibition Place, or products and sponsors related to Toronto FC and the Toronto Marlies.

The Chief Building Official and Executive Director, Toronto Building is recommending that the Council of the City of Toronto amend Chapter 694, Signs, General, of the City of Toronto Municipal Code, in the manner proposed above.

At its meeting to be held in Toronto City Hall, Committee Room 1, on August 7, 2014 commencing at 9:30 a.m., or as soon as possible thereafter, the Planning and Growth Management Committee of Toronto City Council will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
