The proposed multi-service community centre will be developed by the YMCA in partnership with United Way Toronto, the City of Toronto, and a collaborative of local community agencies to provide services such as: community service programs and office spaces, recreation programs, mental health programs, service for individuals with disabilities, outpatient services, medical offices, food security programs, settlement programs, employment training, arts & culture programs and potential ancillary retail uses (i.e. cafeteria, dispensing pharmacy).



before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
