

# STAFF REPORT ACTION REQUIRED

### By-law Amendments for Installed and Approved Contraflow Bicycle Lanes

#### **SUMMARY**

This staff report is about a matter for which Toronto and East York Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain authority to amend the traffic regulations for several existing contra-flow bicycle lanes and to amend parking and traffic regulations required to implement contra-flow bicycle lanes previously approved by Council.

City Council previously approved contra-flow bicycle lanes on Argyle Street, Glen Cedar Road, Gladstone Avenue, Fermanagh Avenue, Florence Street, Havelock Street, Lindsey Avenue and Waterloo Avenue. However, the bicycle lanes were not installed due to minor inconsistencies between the City's approaches to contra-flow bicycle lanes and the provisions of the Ontario Highway Traffic Act (HTA). These inconsistencies were resolved in 2013 in consultation with the Ministry of Transportation and implementation of these approved contra-flow lanes can now proceed. This report describes the amendments to parking and traffic regulations required to install the contra-flow bicycle lanes.

In addition, traffic regulations must also be amended for the existing contra-flow bicycle lanes on Chester Hill Road, Knox Avenue, Logan Avenue, Montrose Avenue and Strathcona Avenue to ensure consistent regulations for all streets with contra-flow bicycle lanes.

#### RECOMMENDATIONS

### The Director, Transportation Infrastructure Management recommends that Toronto and East York Community Council:

- 1. Amend the traffic and parking regulations for the existing and approved contraflow bicycle lanes as described in Appendix 1 – Traffic and Parking Regulations to be Rescinded, and Appendix 2 - Traffic and Parking Regulations to be Enacted, attached to this report.
- 2. Authorize and direct the appropriate City Officials to take the necessary action to give effect to Recommendations No. 1, including introduction of all necessary bills.

#### **Financial Impact**

There are no financial impacts resulting from the adoption of the recommendations of this report. Funds are contained in the Transportation Services 2014 Approved Capital Budget in Cycling Infrastructure Account CTP 814-05 to implement the recommendations of this report.

#### **DECISION HISTORY**

City Council, at its meeting on August 5 and 6, 2009, adopted as amended the staff report, titled "2009 Bikeway Network Program – Installation of Bicycle Lanes" (PW25.20) authorizing the installation of contra-flow bicycle lanes on several streets, including; Argyle Street, Glen Cedar Road, Fermanagh Avenue, Florence Street, Gladstone Avenue, Havelock Street and Lindsay Avenue. These contra-flow bicycle lanes have not yet been installed.

#### **ISSUE BACKGROUND**

Between 1997 and 2007, City Council approved contra-flow bicycle lanes that were subsequently installed on Knox Avenue, Logan Avenue, Montrose Avenue and Strathcona Avenue. In 2009 Council approved several new contra-flow bicycles; however, they were not installed due to concerns that the City's longstanding approach to contra-flow bicycle lanes was inconsistent with Section 153 of the Ontario Highway Traffic Act (HTA). Section 153 states that "...where a highway has been designated for the use of one-way traffic only... vehicles and street cars shall be driven only in the direction designated." However, HTA Section 154 (1) enables municipalities to designate any lane for "...traffic moving in a particular direction or classes or types of vehicles." In 2013 Ministry of Transportation officials confirmed that a contra-flow bicycle lane can be established by designating a traffic lane in one direction only (rather than designating the street one-way) and designating a bicycle lane one-way in the opposite direction. The street would effectively be a two-way street; with bicycles permitted to travel in both directions and motor vehicles permitted to travel in one direction only. All of the existing signage associated with Toronto's one-way streets would remain in place and the street would look and operate just like a one-way street for motor vehicles.

#### COMMENTS

With the resolution of the "HTA concern" regarding contra-flow bicycle lanes, Transportation Services is planning to install the previously approved contra-flow bicycle lanes, as described in this report. In addition, this report recommends amendments to traffic regulations for existing contra-flow bicycle lanes to ensure consistent regulations for all streets with contra-flow bicycle lanes.

#### **Approved Contra-flow Bicycle Lanes**

In the Toronto East York District, contra-flow bicycle lanes have been approved but not yet installed at the following locations.

At the above locations the one-way designations must be rescinded and replaced by designating the general-purpose traffic lane in one direction only (rather than designating the street one-way). The approved contra-flow bicycle lane has already been designated as one-way in the opposite direction. The street would effectively be a two-way street; with bicycles permitted to travel in both directions and motor vehicles permitted to travel in one direction only. All of the existing signage associated with Toronto's one-way streets would remain in place and the street would look and operate just like a one-way street for motor vehicles.

Several of the streets where contra-flow lanes will be installed currently have alternate-side parking in effect. This reports recommends amending the parking regulations, where necessary, to maintain the parking on one side of the street at all times to accommodate the contra-flow bicycle lanes, as described in Appendix 2 attached to this report. Public consultation has been undertaken for all locations where alternate-side parking will be replaced by parking fixed on one side of the street.

New stop signs must be installed at the locations listed in Table 3 below to manage contra-flow cycling traffic in the contra-flow bicycle lanes.

The contra-flow bicycle lanes approved (but not installed) by Council in 2009 were the result of the West End Bikeways study. The study was a participation-focussed planning exercise, which included both a public meeting on Tuesday March 10, 2009 and multiple community surveys to help develop the recommended bikeway routes in the study area. However, given the considerable time that elapsed since the study consultation process was completed, Transportation staff worked with the affected Ward Councillors to conduct community meetings in 2014 to notify residents of the approved routes, and to receive their input on the detailed design for these cycling routes. Community meetings were held on the following dates:

- February 5, 2014 for the Fermanagh route;
- February 27, 2014 for the Argyle-Florence-Waterloo-Gladstone route; and
- March 4, 2014 for the Lindsey-Havelock route.

Transportation staff will continue to work with Ward Councillors to conduct community consultation on the detailed design of the other contra-flow bicycle lanes prior to installation of the route.

#### **Existing Contra-flow Bicycle Lanes**

In the Toronto East York District, contra-flow bicycle lanes are installed at the following locations.

To ensure consistent regulations for all streets with contra-flow bicycle lanes, the one-way designation must be rescinded and replaced by designating the shared traffic lane in one direction only (rather than designating the street one-way). The only change to the current signage will be the addition of a "bicycles excepted" tab to the one-way arrow sign.

The affected Ward Councillors have been consulted in the preparation of this report.
