

# STAFF REPORT ACTION REQUIRED

## Realignment of Permit Parking Area "8C" to exclude 1220-1230 Dundas Street East

## SUMMARY

Transportation Services is requesting authority from City Council to amend the boundary of Permit Parking Area 8C.

Transportation Services has assessed the realignment of Permit Parking Area 8C to exclude the property located at 1220 - 1230 Dundas Street East as requested by Toronto and East York Community Council on May 13, 2014. We are recommending approval of the realignment as it will not impact negatively on the Permit Parking Area.

#### RECOMMENDATIONS

## **Transportation Services recommends that:**

1. City Council authorize the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "8C", as attached in Appendix "A" of the report (May 26, 2014) from the Manager, Right of Way Management, Transportation Services, Toronto and East York District.

#### FINANCIAL IMPACT

There is no financial impact associated with this report.

#### **ISSUE BACKGROUND**

Toronto and East York Community Council at its meeting of May 13, 2014 in considering the final report for the zoning amendment – 1220 – 1230 Dundas Street East, item TE32.11 requested Transportation Services to examine and report back to Toronto and East York Community Council on June 17, 2014 regarding the realignment of parking area 8C and the exclusion of the subject site 1220 – 1230 Dundas Street East from the Permit Parking area.

#### COMMENTS

Permit Parking area 8C is bounded by Dundas Street East, the CN Railway and Coxwell Avenue. Area 8C has 1,966 on-street parking spaces. To date, 1,607 permits have been issued. This area does not have a history of being waitlisted, meaning the demand for overnight on-street parking permits has never exceeded the supply of parking spaces. There is TTC service on Dundas Street East. The Councillor and residents neighbouring 1220 - 1230 Dundas Street East support this action as a means of ensuring that this new development does not negatively impact the Permit Parking supply to the existing neighbourhood.

Transportation Services has no objection to the exclusion of 1220-1230 Dundas Street East from permit parking area "8C".
