### **Toronto Parking Authority - 2015 Recommended Operating Budget, and the 2015 Recommended Capital Budget and 2016 - 2024 Recommended Capital Plan**

#### **2015 Toronto Parking Authority Rates Toronto Municipal Code, Chapter 441, Fees and Charges**

Toronto City Council will be considering Toronto Parking Authority – 2015 Recommended Operating Budget, and the 2015 Recommended Capital Budget and 2016 - 2024 Recommended Capital Plan on March 10 and 11, 2015.

Notice is hereby given that City officials are not recommending any changes to the maximum hourly on-street parking rate as outlined in City of Toronto Municipal Code Chapter 441, Fees and Charges, Appendix G - Schedule 1, Toronto Parking Authority.

The Budget Committee has established two subcommittees to hear public deputations on the 2015 Capital, Operating and Rate Supported Budgets. The Budget Subcommittee for City Hall and Scarborough Civic Centre Consultation and the Budget Subcommittee for Etobicoke and North York Civic Centres Consultation will receive presentations from any person, or their counsel, agent or solicitor, who wishes to speak to the matter at one the following meetings:

The Budget Committee will make its final recommendations on February 20, 2015, which will be forwarded for consideration by the Executive Committee at its special meeting on March 2, 2015 and then to City Council at its special meeting on March 10 and 11, 2015. The adopted fees will be implemented through a by-law that will amend the Municipal Code, if necessary

While the 2015 Toronto Parking Authority Recommended Operating Budget does not recommend any rate change, the appropriate Committee may change these recommendations and Toronto City Council may adopt rates that differ from the recommendations, including rates that are higher or lower, and may adopt new rates.
