

Public Notice

2016 Rate Supported Budgets - Solid Waste Management Services and Recommended 2016 Solid Waste Rates

Notice is hereby given that City officials are recommending to Toronto City Council the enactment of a by-law amending the City of Toronto Municipal Code Chapter 441 - Fees and Charges; and any other Municipal Code Chapters as may be required to give effect to the following as of January 1, 2016:

- an increase of 3% to all Solid Waste Management Services rates and fees listed in Schedule 1 of Appendix A to Chapter 441 of the Code as of the date of this notice (available at http://www.toronto.ca/legdocs/municode/1184_441-a.pdf)

Changes to the Solid Waste Rebate for Single Family Residential Customers will be considered during City Council's review of the Tax Supported Operating Budget launching on December 15, 2015. A further Public Notice with the specific details will be given at that time.

The attached Appendix A provides:

- examples of the 3% increase to key Solid Waste Management Services Rates and Fees set forth in Schedule 1 of Appendix A to Code Chapter 441 as of the date of this notice.

The particulars of the proposed Solid Waste Management Services rates and fees are set out in the report to the Budget Committee of Toronto City Council from the Deputy City Manager and Chief Financial Officer and the Acting General Manager, Solid Waste Management Services entitled "Recommended 2016 Solid Waste Rates ", (the "Report").

Any comments received after the Committee meetings will be forwarded to City Council.

The Budget Committee will make its final recommendations on November 24, 2015, which will be forwarded for consideration by the Executive Committee at its meeting on December 1, 2015 and then to City Council at its meeting on December 9 and 10, 2015.

The adopted fees will be implemented through a by-law that will amend the Municipal Code, if necessary.

While the Recommended 2016 Solid Waste Rates report sets out the recommended rates and fee increases, the appropriate Committee may change these recommendations.

Further, Toronto City Council may adopt rates and fees that differ from the recommendations, including rates and fees that are higher or lower than the rates and fees set out in the Report, changes to rates and fees for which no change is recommended, and may adopt additional new rates or fees.
