

Appendix A

Proposed 2016 Solid Waste Rates and Fees

This Appendix illustrates various aspects of the Public Notice hereby given. City officials recommend that the Council of the City of Toronto pass a by-law to increase current Solid Waste Rates and Fees, introduce new Solid Waste Rates and Fees all effective January 1, 2016:

1. Examples of Key Solid Waste Rates and Fees proposed to increase by 3%

As stated in the Public Notice, City officials are recommending a 3% increase to all current Solid Waste Rates and Fees set forth in Schedule 1 of Appendix A to Chapter 441 of the Toronto Municipal Code (the "Schedule"). Below are examples of several key Solid Waste Rates and Fees from the Schedule with the 3% cent increase applied. Please note that the remaining rates and fees found on the Schedule but not listed below also have been recommended to increase by 3%.
