SUMMARY

At its meeting held on September 8, 2015, Etobicoke York Community Council considered Item EY8.61 – Parking Regulation Amendments – Milvan Drive and Millwick Drive, and recommended that City Council adopt the recommendation contained therein. Following adoption of this Item, errors were identified with respect to parking by-laws on Milvan Drive set out in Appendices "A" and "B" to the staff report. As such, corrections are required to the "No Parking" regulations to be rescinded and enacted in Appendices "A" and "B", respectively. These corrections do not substantially change any of the "No Standing" and "No Parking" prohibitions proposed to address the concerns of the business owners about parked vehicles on Milvan Drive and Millwick Drive and to improve traffic operations on these sections of the roads.

RECOMMENDATIONS

The General Manager, Transportation Services recommends that:

1. City Council replace Appendices "A" and "B" to Etobicoke York Community Council Item EY8.61 and to the report (July 20, 2015) from the Director, Transportation Services - Etobicoke York District, with the revised Appendices "A" and "B" attached to the report dated September 23, 2015 from the General Manager, Transportation Services.

Financial Impact

There is no financial impact associated with the staff recommendation.

The Etobicoke York Community Council, at its meeting held on September 8, 2015, considered Item No. EY8.61, entitled "Parking Regulation Amendments - Milvan Drive and Millwick Drive".
