**SUMMARY**

At its meeting held on September 17, 2015, the Government Management Committee considered Item GM6.24– Changes to the On-Street Parking Machine Rates and Hours of Operation, and recommended that City Council adopt the recommendations contained therein. Following adoption of this Item, changes were identified with respect to parking by-laws as set out in Appendices "1" and "2" to the staff report. As such, the removal of changes to parts of Yorkville, as well as other administrative changes were identified after the report was considered. These corrections do not substantially change any of the proposed changes outlined in the report.

**RECOMMENDATIONS**

**The President, Toronto Parking Authority recommends that:**

1. City Council replace Appendices "1" and "2" to Government Management Committee Item GM6.24 and to the report (September 2, 2015) from the President, Toronto Parking Authority, with the revised Appendices "1" and "2" attached to the report dated September 29, 2015 from the President, Toronto Parking Authority.

Appendices "1" and "2" to Item GM6.24 contained proposed amendments to parking regulations as part of the Changes to the On-Street Parking Machine Rates and Hours of Operation report. Following adoption of the staff report by Government Management Committee, some minor required changes to the parking regulations to be rescinded and enacted were identified. These Appendices are being revised to remove changes with respect to parking regulations in Yorkville (Bellair St., Cumberland St., Yorkville Ave.) to reflect amendments adopted by Toronto and East York Community Council on September 8, 2015 (Item TE10.80), and to include minor parking amendments to Yonge St. (south of Lawrence), Bloor St. E., and Elizabeth St., in accordance with the changes outlined in the body of the staff report.
