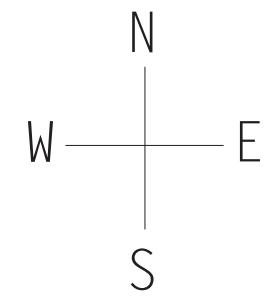
Details we have been made aware of regarding the event are as follows:

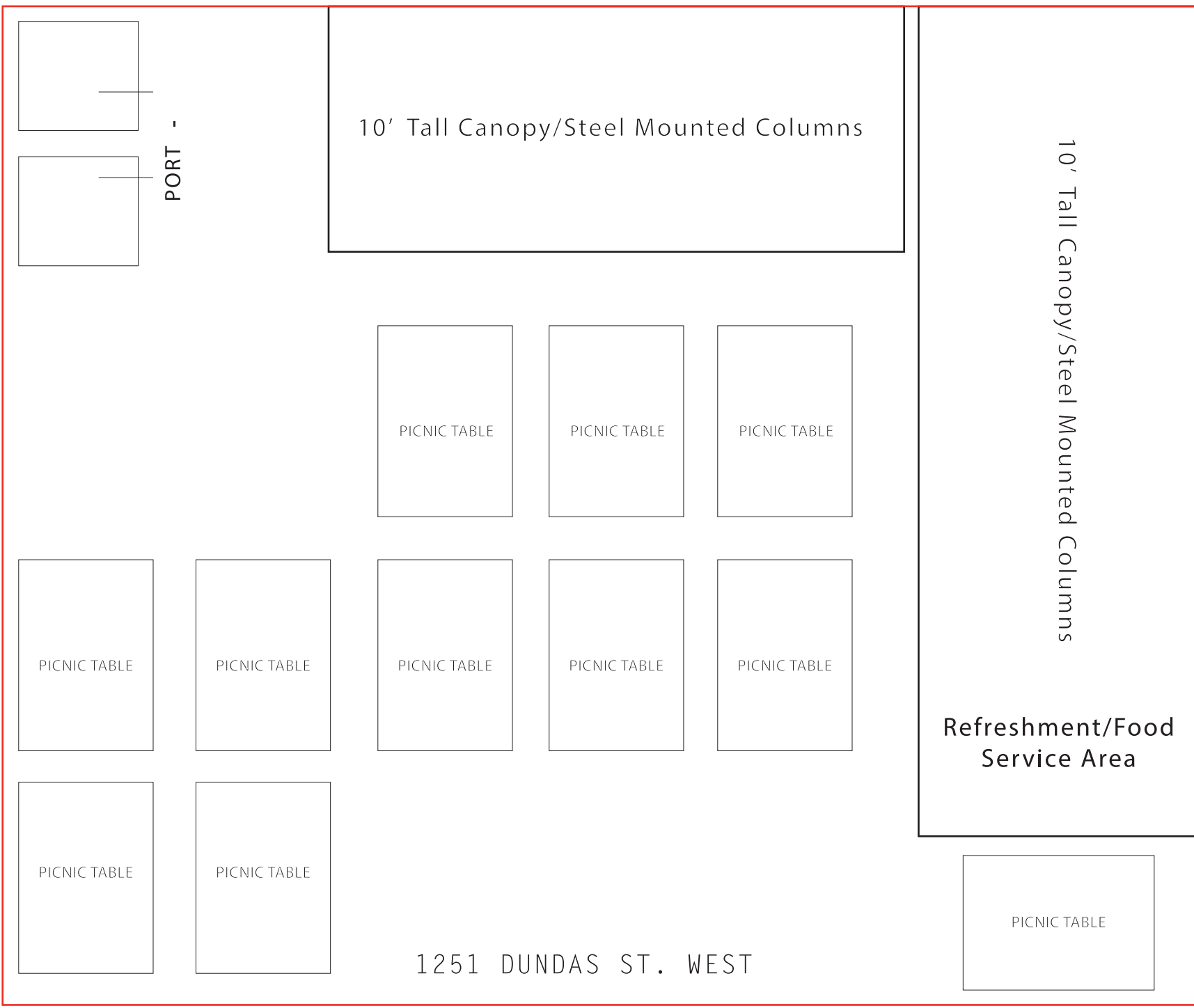
