The existing dwelling and detached garage will be demolished and the property will be redeveloped as the site of a new detached dwelling with an integral garage, requiring variances to the Zoning By-law, as outlined in Application Number A171/15EYK.

File numbers B18/15EYK, A170/15EYK and A171/15EYK will be considered jointly.

- The suitability of the dimensions and shapes of the proposed lots has not been demonstrated.
