SUMMARY

In its meeting of January 5, 2015, The Government Management Committee:

1. Requested the Director, Facilities Management and the Chief Information Officer to report to the February 17, 2015 Government Management Committee meeting on Item GM18.15 titled "Installation of Additional Electrical Outlets in City Hall Council Chambers and Expansion of the Public Wi-Fi Service" which was received by the Government Management Committee on November 15, 2012, including the overall cost of the project implementation as well as the number of electrical outlets and their locations in the City Council Chamber.

RECOMMENDATIONS

The Chief Corporate Officer recommends that:

1. The Government Management Committee receive this report for information.

Financial Impact

In 2015, there will be additional electrical outlets to be installed for public use in each of the three public seating sections of Council Chamber. Two additional duplex electrical outlets will be installed in the front row. This will result in an additional 12 electrical outlets available for the public. The project cost is estimated to be \$10,000.00. Funding is available in the 2015 Recommended Operating Budget for Facilities, Real Estate, Environment & Energy under cost centre FA0013.

The Deputy City Manager & Chief Financial Officer has reviewed this report and agrees with the financial impact information.

DECISION HISTORY

At its meeting of November 15, 2012, Government Management Committee received the report titled "Installation of Additional Electrical Outlets in City Hall Council Chambers and Expansion of the Public Wi-Fi Service" advising of staff plans to install additional electrical outlets in the City Hall Council Chamber, and to implement an expanded free Wi-Fi service for the public to gain Internet browsing access in the general public areas within City Hall, and the Etobicoke, Scarborough and North York Civic Centres.

COMMENTS

The scope of work of the installation of additional electrical outlets in the City Hall Council Chamber included a total of 12 electrical outlets and 8 USB outlets, half of these are positioned near the east council elevator and the other half positioned near the west council elevator on the Members Lounge level of Council Chamber.

The cost to install these additional electrical outlets in the City Hall Council Chamber was \$6,132.00 and the installation work was completed in 2014.

In 2015, additional electrical outlets will be installed for public use in Council Chamber. In each of the three public seating sections of Council Chamber, two additional duplex electrical outlets will be installed in the front row. This will result in an additional 12 electrical outlets available for the public. The estimated cost for this additional work is approximately \$10,000.00.

CONCLUSION

The installation of additional electrical outlets in the City Hall Council Chamber which was completed in 2014, included a total of 12 electrical outlets and 8 USB outlets for a cost of \$6.132.00. Additional outlets will be provided in 2015 at a cost of \$10,000.00.
