**Changes to the On-Street Parking Machine Rates and Hours of Operation  
Chapter 910, Parking Machines and Meters**

**Toronto City Council will be considering recommendations to pass by-laws to amend the City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, so as to incorporate changes to the hourly rates and hours of operations.**

The proposed changes are detailed in the report entitled, Changes to the On-Street Parking Machine Rates and Hours of Operation and a schedule setting out the list of proposed by-law amendments to be enacted is attached to the report as Appendix 2.

It is proposed that the by-laws be adopted at the City Council meeting to be held on September 30, 2015 or at a subsequent meeting.

At its meeting to be held in Committee Room 2, Toronto City Hall on September 17, 2015, at 9:30 a.m. or as soon as possible thereafter, the Government Management Committee of Toronto City Council will hear in person, or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
