Re: **MM7.1** Request to Protect 250 year old Red Oak Tree at 76 Coral Gable Drive  
City Council Meeting No. 7: June 10, 2015

CORRA, the Confederation of Resident and Ratepayer Associations in Toronto, received communication from member associations and interested parties concerned with the need to protect a 250 year old Red Oak Tree, potentially the oldest and largest Red Oak in the City.

CORRA historically has spoken on behalf of groups that may not have a voice and among these groups we include the environment and in this case a significant 250+ year old Red Oak tree located in North York at 76 Coral Gable Drive, This particular tree has already been recognized and designated as a Heritage Tree under Forests Ontario's Heritage Tree program; a living monument worthy of preservation for current and future generations.

The stewardship / protection of the natural environment consisting of the Toronto's ravines, open space, park land and trees in a built up urban environment are not localized issues but are City-wide.

CORRA is in support of resident and ratepayer groups, Cabbagetown ReLeaf, Forests Ontario and the Ontario Urban Forest Council in requesting that:

1. Council secure the protection of this significant Red Oak Tree, including the direction of staff to initiate the acquisition of the property; and

In addition to No. 1 above, CORRA also request that:

2. Council initiate the process to protect this site as a cultural and natural heritage site as recognized in the Heritage Act under Cultural Heritage Landscapes and be designated as such with the City Clerk.

To Members, Resident and Ratepayer Executives:

Your help is needed to protect a 250+ year old Red Oak Tree located in North York at 76 Coral Gable Drive, as it may be threatened. The facts about this particular tree are:

- It is the largest and oldest Red Oak in the City of Toronto (and possibly in Ontario)
- It is estimated to be between 250 and 350 years old.
- The tree is already designated as a Heritage Tree under Forest Ontario's Heritage Tree program,
- The tree's location is near the historic Toronto Carrying Place Trail,
- The tree is an important and irreplaceable as a living monument of Toronto's heritage,
- The tree stands as a tribute to Canada's history and having survived the harshest conditions, has demonstrated genetic superiority, a quality worthy of recognition given our changing climate

Recommendations:

1. To support the City of Toronto's proposal to obtain the property in order to prevent any action that may harm or make application for the injury or its removal;
2. The site should be preserved as a cultural and natural heritage site as recognized in the Heritage Act under Cultural Heritage Landscapes and be designated as such with the City Clerk; and
3. To support any regulatory or multi-tier government approach to protect this Heritage Tree.
