The Cypriot Cultural Festival is one of our fundraising events and is aiming at maintaining and promoting our heritage and culture.



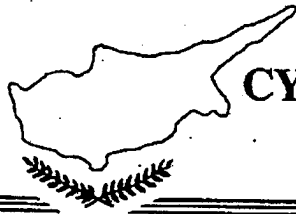
