### 2014-10-1 ADOPTION OF AGENDA:

It was moved by S. Ghose and seconded by M. A. Cross that the proposed agenda be adopted, as amended. Carried.

### 2014-10-4 Panel Initiatives

### 10.4.1Leaside (Ward 26)

#### **10.4.1.1** Leaside Heritage Conservation District Nomination

G. Kettel reported that the consultant is working on another draft of his report. Nominated HCD candidates have been asked to complete a questionnaire which will be used to determine priorities for HCD studies.

#### 10.4.2 Connaught Labs Centennial (Sanofi Pasteur)

Opinions were expressed that the public event held on November 13 was of excellent quality and well-received. G. Kettel reported that Sanofi Pasteur had arranged for videotaping of the event.

10.5.1 Ward 24

### 10.5.1.1 591 and 593 Sheppard Avenue East and 9 Barberry Place (Thomas Clark House)

The Heritage Impact Assessment for the 591 and 593 Sheppard Ave. East development is still awaited.

# 10.5.2 Ward 26

## **10.5.2.1 262 Bessborough Drive (Thomas G. Elgie House)**

G. Kettel reported that the there is no word on the status of the conservation management plan that is required to be submitted before the owner can apply for a heritage permit for alterations.

# **10.5.2.2 146-150 Laird Drive zoning by-law amendment** application

G. Kettel reported that the staff reports requested by the Panel on the heritage assessments of the two properties (of which only 150 Laird Drive is currently listed), were expected to come forward in the spring of 2015.

# 10.5.3 Lane/Street Naming

### 10.5.3.1 Proposed public street and public lane at 238-258 Finch Avenue East, just east of Maxome Avenue (Ward 24)

Engineering Services has not yet heard back from Councillor Shiner regarding the Panel's recommended names of "Munshaw" and "Pahtahsega" or "Peter Jacobs". A descendant of George Elliott has been located through Ancestry.ca so that name will be recommended as another choice for the street and lane naming. George Elliot was not only an early landowner on the development site, but also Deputy Reeve of North York from 1929-1930, and Reeve from1931- 1933.

**10.5.3.2** Unassumed Street between Rean Drive and Barberry Place just south of Sheppard Avenue East (Ward 24) Research is ongoing to locate a descendant of Thomas Clark in order to meet the Honourific and Street Naming Policy requirement.

# 10.5.3.3Proposed Public Street for a Draft Plan of a<br/>Subdivision at 50 Kenton Drive (Ward 23)

The Panel recommended "Captain Daniel Cozens" for the name of the street, but it was modified to "Daniel Cozens" by Engineering Services, with the explanation that the City prefers not to use honourifics. Since Engineering Services, the developer, and Councillor Filion all supported the name, the developer was notified that the name "Daniel Cozens Court" was authorized for use on the draft Plan of Subdivision.

# 10.5.3.4Proposed Street Names for Development at 1201Wilson Avenue (Ward 9)

No decision has been made regarding the Panel's recommended names of "Peter Wardlaw" and "Robert Carruthers" or "Petherhilll Farm", the name of the home built by James Carruthers. Councillor Augimeri has no objection to the suggested names associated with the early settlers of the area.
