We are, however, disappointed to learn GYRA's efforts for inclusion of Yonge Street, north of Bloor to Davenport Road is excluded. However, we note the recommendation to consider individual listing on the Heritage Register for the block, on the west side of Yonge, between Cumberland and Yorkville.

Having lost so much of our low-rise century old retail buildings to rapacious high-rise developers, preserving what remains of Toronto's heritage built form is crucial.
