6.5.1.1 C-I-L House Open Space (Sheppard Ave. at Doris

6.5.5.1 1299 Don Mills Road (George Gray House)

G. Kettel reported that on July 7, 2015, City Council adopted the staff report recommending inclusion of the property on the Register of Heritage Properties.

6.5.6 Lane/Street Naming

6.5.6.1 Naming of a Proposed Street at the Development at 1185 Eglinton Avenue East (Ward 26)

The Panel does not support the name "Sonic" proposed by the developer. It does not add meaning to the site, unlike a heritage name, and brings to mind, "Sonic, the Hedgehog".

The Panel recommends that the street be named either after a member of the Taylor family or to recognize Sports Alliance Ontario.

The Taylor family made significant contributions to the pioneer community that is now part of North York. John Taylor and his brothers Thomas and George, owned land at the site as well as three paper mills, and a grist mill on the Don River. George provided funding for the construction of the first brick Don Mills Primitive Methodist Chapel, later replaced by the current Don Mills United Church building. In 1860, the three Taylor brothers granted a new deed to the Trustees of the Church, apparently to settle the exact boundaries of the church property.

William Taylor, one of George's sons, found clay good for making red bricks when digging fence post holes in 1882, and founded the Don Valley Brick Works (now the Evergreen Brick Works) with his brothers John F. Taylor, and George A. Taylor in 1889. It was one of the oldest and largest brick works in the province and the longest operating facility in Toronto and Ontario, remaining in operation until the 1980s. The bricks made were of such good quality that they won prizes at the 1893 Chicago World's Fair and the 1894 Toronto Industrial Fair.

John Taylor was a pioneer in the technical development of Canada's paper industry, being the first to develop and later patent a method of making paper from wood pulp instead of rags, in response to an 1854 English contest offering a reward of £1,000 to anyone who could find a substitute for rags as a raw source for paper.

The name "Ontario Sport" was also suggested, to recognize Sports Alliance Ontario and the site's long term association with multi-sports. Sports Alliance Ontario was for many

years the main tenant in a 10-storey office building formerly located on the site prior to being demolished. Sports Alliance Ontario had building naming rights and the sign was visible from the Don Valley Parkway. This name would acknowledge the site's long term association with multi-sports.

The names were discussed and "Ontario Sport" will be submitted to Land and Property Surveys, Engineering and Construction Services, in addition to names associated with the Taylor family.
