Note: 1) The <b>storm sewer</b> , such as the square grates on the sides of the roads and in parking lots, leads directly to the nearest creek, river and eventually to Lake Ontario. Carwash and floor washing wastewater is not permitted to be drained outside to the storm sewer.							
2) The <b>sanitary sewer</b> leads to the wastewater treatment plants where the wastewater is treated before discharging to Lake Ontario. Hazardous materials like fuel and solvents should not enter the sewer as it may harm the sewage treatment process and the natural environment.
