# **Business Improvement Area Boards of Management -** 2015-2018 Appointments

## **SUMMARY**

The purpose of this report is to recommend Scarborough Community Council appoint members to the Board of Management for the new term of Council for the Sheppard East Village Business Improvement Area (BIA) which falls within the Scarborough Community Council boundaries. The Scarborough Community Council has delegated authority to make final decisions regarding BIA appointments.

### RECOMMENDATIONS

The Director, Business Growth Services, Economic Development and Culture, recommends that:

- 1. Scarborough Community Council appoint the nominees listed in Attachment No. 1 to the Board of Management for the Sheppard East Village BIA for a term expiring at the end of the term of Council or as soon thereafter as successors are appointed.
- 2. Scarborough Community Council confirm that under Council's Public Appointments Policy, these Board members are appointed at the pleasure of Community Council, and Community Council retains the right to replace any appointed member at any time and for any reason; and
- 3. Scarborough Community Council direct that Schedule A of the Municipal Code Chapter 19, Business Improvement Areas, be amended to reflect the change in the number of members required for quorum for the Sheppard East Village BIA Board of Management.

## **Financial Impact**

There are no financial implications resulting from the adoption of this report.

#### **DECISION HISTORY**

Municipal Code Chapter 19 states that the term of BIA Board of Management appointments expire with the term of Council. In an election year, BIAs are required to elect nominees for appointment to the next Board of Management at an Annual General Meeting (AGM).

In some cases, BIAs voted to alter the size of their Board of Management or quorum. Amendments are required to Schedule A of Municipal Code Chapter 19, which prescribes the number of members of each BIA Board of Management and number of members required for quorum.

On January 6, 2015, the Sheppard East Village BIA held its 2014 Annual General Meeting and nominated eight (8) BIA members for their Board of Management. The nominees listed in Attachment No. 1 meet the requirements for membership of a BIA Board as set out in Chapter 19 of the Municipal Code. Scarborough Community Council has authority to appoint these nominees.

#### ISSUE BACKGROUND

There are four (4) BIAs within the geographic area of the Scarborough Community Council and all four (4) have held their 2014 Annual General Meetings. At its meeting on January 13, 2015, Scarborough Community Council adopted the recommendations of a report regarding the 2015-2018 Board of Management nominees for the Crossroads of the Danforth, Kennedy Road and Wexford Heights BIAs. On January 6, 2015, the Sheppard East Village BIA held its 2014 Annual General Meeting and nominated eight (8) BIA members for their Board of Management. Scarborough Community Council has authority to appoint these nominees
