Notice was given and a Public Hearing was held on Wednesday, March 18, 2015, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

To construct a new detached dwelling. Note: On November 20, 2014, the Committee of Adjustment refused variances to lot coverage and floor area (File A229/14SC). A new application has been submitted and the proposal remains the same as the previous application.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:**By-law 569-2013 and By-law 8786**

1. The proposed coverage is 47.5% of the lot area.
Whereas the maximum permitted coverage is 33% of the lot area.
2. The proposed floor area is 0.869 times the lot area (202 m²).
Whereas the maximum permitted floor area is the lesser of 0.6 times the lot area (139.97 m²) or 204 m².

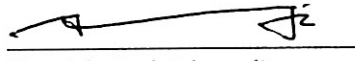
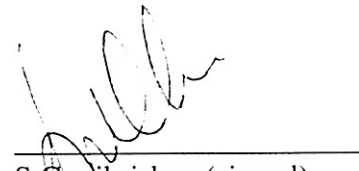
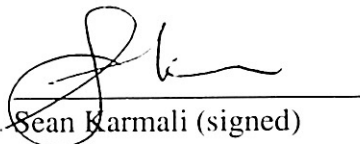
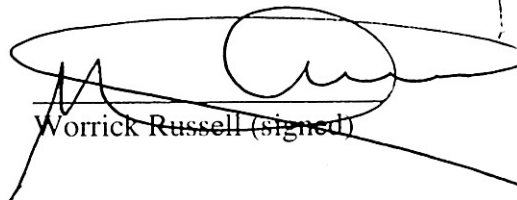
IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:**The Minor Variance Application is Refused**
