PURPOSE OF THE APPLICATION:

To construct a new detached dwelling.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

By-law 569-2013 and By-law 8786

- 1. The proposed coverage is 47.5% of the lot area. Whereas the maximum permitted coverage is 33% of the lot area.
- 2. The proposed floor area is 0.869 times the lot area (202 m²). Whereas the maximum permitted floor area is 0.6 times the lot area (139.97 m²) or 204 m².
