SUMMARY

This report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This report responds to a request for parking restrictions on Huntingdale Boulevard, in order to improve driveway access sightlines.

It is recommended that "No Parking" regulations be implemented on the south side of Huntingdale Boulevard, within the vicinity of the driveway to 65 Huntingdale Boulevard. In addition, it is recommended that existing parking by-laws be amended along the entire length of Huntingdale Boulevard between Pharmacy Avenue and Bridletowne Circle in order to be consistent with other existing parking signage on Huntingdale Boulevard and to improve sightlines and safety.

RECOMMENDATIONS

Transportation Services recommends that Scarborough Community Council:

- 1. Rescind the no parking at all times regulation on the south side of Huntingdale Boulevard, from Pharmacy Avenue to Bridletowne Circle.
- 2. Prohibit parking at all times on the south side of Huntingdale Boulevard, from Pharmacy Avenue to a point 132 metres east.
- 3. Prohibit parking at all times on the south side of Huntingdale Boulevard, from a point 170 metres east of Pharmacy Avenue to a point 37.5 metres further east.

- 4. Prohibit parking at all times on the south side of Huntingdale Boulevard, from a point 250 metres east of Pharmacy Avenue to a point 25 metres further east.
- 5. Prohibit parking at all times on the south side of Huntingdale Boulevard, from a point 397 metres east of Pharmacy Avenue to a point 42 metres further east.
- 6. Prohibit parking at all times on the south side of Huntingdale Boulevard, from Bridletowne Circle to a point 27 metres west.

Financial Impact

The financial cost of installing the subject parking prohibition signs is approximately \$750.00. Funds for these signs are included in the Transportation Services 2015 Operating Budget, within Cost Centre TP0397.

ISSUE BACKGROUND

Further to request from an area resident regarding restricted access to and sightline issues at a driveway, Transportation Services reviewed the feasibility of parking prohibitions on Huntingdale Boulevard. Staff have determined that the parking restriction would be beneficial for accessing the driveway to 65 Huntingdale Boulevard and improving sightlines at this location.

In addition, upon a routine review of existing parking by-laws for the subject street and other existing parking signage, staff have identified the need to modify parking by-laws along the entire length of Huntingdale Boulevard between Pharmacy Avenue and Bridletowne Circle in order to be consistent with the existing parking signage.

COMMENTS

The following characteristics describe this section of Huntingdale Boulevard:

- Huntingdale Boulevard is located north of Finch Avenue, east of Pharmacy Avenue and west of Warden Avenue.
- Huntingdale Boulevard is a two-lane two-way collector road with an unposted regulatory speed limit of 50 km/h.
- Sidewalks are in place on both sides of Huntingdale Boulevard.
- The land use on Huntingdale Boulevard is a mix of single family residential and mid-rise residential.

Traffic Operations staff anticipate that the proposed parking restrictions will improve driveway sightlines for motorists and improve safety for pedestrians.
