The applications to amend the Official Plan and Zoning By-law for the property at 3445 Sheppard Avenue East propose to permit 295 residential units in two residential buildings of 14 and 10 storeys with ground floor commercial uses fronting Sheppard Avenue East and 4 blocks of stacked townhouses containing 57 units at the rear of the site. A total of 352 residential units, 374 vehicular parking spaces and 303 bicycle parking spaces are proposed.
